EXHIBITOR INFORMATION

We are looking forward to your participation in the Annual Session of the Great Lakes Association of Orthodontists at the Hyatt Regency Indianapolis in Indianapolis, Indiana on October 14 - 16, 2021. RENTAL FEE: \$2,500 per booth (\$2,700 after August 5, 2021)

BOOTH REGISTRATION INCLUDES:

- One (1) 8' deep x 10' wide booth, one (1) 6' covered and skirted table (8' high back wall & 3' high side rail drape): Two (2) chairs, one (1) waste basket, one (1) Booth ID sign; Carpeted exhibit hall
- Company and product/service listing in meeting app
- Two (2) exhibitor personnel registrations per booth (additional personnel may register for \$200 per person)
- Two continental breakfasts, two lunches, daily beverage breaks and tickets to the Friday evening Social Event
- Doctor attendee labels, if requested when registering

BOOTH ASSIGNMENTS: Booth assignments will be based on the date the completed "GLAO Exhibitor Contract" AND payment are received. If more than one contract is received on the same day, priority assignment will be made based on prior exhibit history. Priority placement will be given to sponsors and according to level of sponsorship. For multiple booths, assignments will be made within the same row and not on the end caps. Confirmation of booth assignment, an Exhibitor Service Kit, and a link to register representatives, will be emailed by August 31st, to the individual indicated on the contract.

TEARDOWN: Saturday, October 16, from 2:00 pm - 4:00 pm.

CERTIFICATE OF INSURANCE: A Certificate of Insurance must be provided to the GLAO office no later than September 2, 2021. All exhibitors and display houses must provide certificates to be admitted to the hall. Certificates are to name the Great Lakes Association of Orthodontists as additional insured with policy date through October 16, 2021. Coverage should include comprehensive general liability of at least \$1,000,000 per occurrence. Workman's Compensation should be for full compliance employees for any work done on the exhibitor's behalf.

CANCELLATION POLICY: A full refund, less a \$100 processing fee, will be issued for cancellations received in writing by August 5, 2021. No refunds will be issued after August 5, 2021. Refunds will be sent within 30 days after the event. Deadline for the 2021 GLAO onsite materials and app will be September 2, 2021.

REGISTRATION: Exhibitor service kits will be sent to the contact on the Exhibitor Contract by August 31st. At that time, the names of those attending will be requested. You may also register for ticketed events at that time.

HOUSING: The Hyatt Regency Indianapolis is the host hotel. Reservations may be made by calling 1-800-223-1234 and requesting the GLAO rate or online through the link found at www.GLAO.org. Make your reservation as soon as possible!

Discounted rates are only available until September 21, 2021 or until the room block is full.

RULES AND REGULATIONS FOR EXHIBITORS

- CONTRACT:** All applicants for exhibit space are required to submit a complete and signed contract. All rules and regulations as outlined with this contract are accepted upon signature by the Exhibitor and made part of this contract.
- FLOORPLAN:** The Great Lakes Association of Orthodontists (GLAO) reserves the right to alter the location of booths as shown on the official floor plan (see Information page for assignment information) and to assign.
- EXHIBITS:** The GLAO shall have the right to determine eligibility & prohibit or remove any exhibit or proposed exhibit, which in the judgment of the GLAO is unsuitable or inappropriate for the exhibition or purposes of such exhibition; and such right shall extend, but not be limited, to persons, equipment, materials, displays, installation and other items constituting part of, or distributed in connection with any such exhibit, without refund. Action may be taken by the GLAO against exhibitors who violate any of the rules or policies, which may include being prohibited from participating in future GLAO Annual Sessions.
- SOLICITATION, CONCURRENT MEETINGS, NON-EXHIBITORS:** Firms and representatives of firms not assigned exhibit space are prohibited from soliciting business during the 2021 Annual Session. Violators will be requested to promptly leave the convention area. No exhibitor shall assign, sublet or apportion the whole or any portion of space allotted, nor shall an exhibitor be permitted to exhibit therein any goods other than those manufactured or distributed by him/her in the regular course of his/her business. Violation of this rule shall be cause for the offender to be asked to leave the show without refund. Displays or demonstrations by exhibitors may not be held in any area other than the exhibit hall. Exhibitors are requested to open hospitality suites or conduct events/meetings only with date and time approved by the GLAO. Deadline for information to be listed in the program is September 2, 2021.
- LIABILITY, INSURANCE & INDEMNIFICATION:** Exhibitor is responsible for all damages to the exhibit premises and for any and all claims and demands on account of any injury or death or damage to property done in or about the premises used by the exhibitor, his employees, servants, agents, licenses or contractors occasioned by their negligence and hereby agrees to indemnify the GLAO, the Hyatt Regency Indianapolis and its employees, agents, or servants, against all claims losses or damages to persons or property and costs defending claims arising out of or caused by any negligence on the part of the exhibitor installation, removal, maintenance, occupancy or use of the exhibition premises or a part thereof. It is the sole responsibility of the exhibitor to obtain proper insurance and to provide proof of insurance, as requested. The exhibitor, upon signing the contract, releases the GLAO or the Hyatt Regency Indianapolis from any and all claims for such loss, damage or injury.
- CERTIFICATE OF INSURANCE: A Certificate of Insurance must be in the GLAO office by September 2, 2021.** All exhibitors must provide a certificate of insurance to be admitted to the hall (see Information page for insurance requirements).
- SECURITY:** The GLAO will not provide Exhibit Hall security. The Exhibit Hall will be locked at night but Exhibitors will be expected to remove valuables (laptops, etc.) from the Exhibit Hall at night. Tables located in the foyer cannot be secured. The GLAO and the Hyatt Regency Indianapolis are not liable for loss, damage, or theft that may be incurred by the exhibitor.
- SHOW HOURS:** Hours for exhibit set-up will be Thursday, October 14, 2021 from 12:00 pm to 5:00 pm. Exhibits will be open Friday, October 15, 2021 from 7:30 am to 4:30 pm; Saturday, October 16, 2021, from 7:30 am to 2:00 pm. Exhibits are to be staffed throughout the show hours. Tear-down may begin on October 16th, 2:00 pm to 4:00 pm. Tear-down is not to begin prior to 2:00 pm. Shipping assistance will be available at that time.
- REFUNDS / CANCELLATION:** A full refund, less a \$100 processing fee, will be issued for cancellations received in writing by August 5, 2021. No refunds will be issued after August 5, 2021. Refunds will be sent within 30 days after the event. Deadline for the printed program and/or app will be September 2, 2021. The GLAO reserves the right to cancel the 2021 Annual Session for any reason. If such a decision is made, all payments will be refunded to exhibitors.
- SET UP & DISMANTLING RESTRICTIONS:** Exhibits must be arranged so as not to obstruct the general view or hide the exhibits of others. To preserve the sight line to the neighboring exhibitor, anything above the height of the table must be placed within the back half of your exhibit space. Any additions or improvements to exhibit space other than included equipment shall be at exhibitor's expense and must comply with fire department and underwriter rules. The aisles, passageways and overhead spaces remain strictly under control of the GLAO. Items will only be permitted in these areas by special permission of the GLAO. Exhibit noise may not interfere with other exhibitors. All items left in hall after dismantling hours will be disposed of or handled at the convention center's discretion at exhibitor's expense. The exhibitor must surrender his display space in the same condition as it was when occupied. Compliance with local fire and state tax ordinances is required.
- CONDUCT:** Exhibitors and their agents are expected to act at all times in a professional manner. Any disruptions or unacceptable conduct may result in ejection from the Exhibit Hall, at the discretion of the GLAO, with no refund of space rental fees.

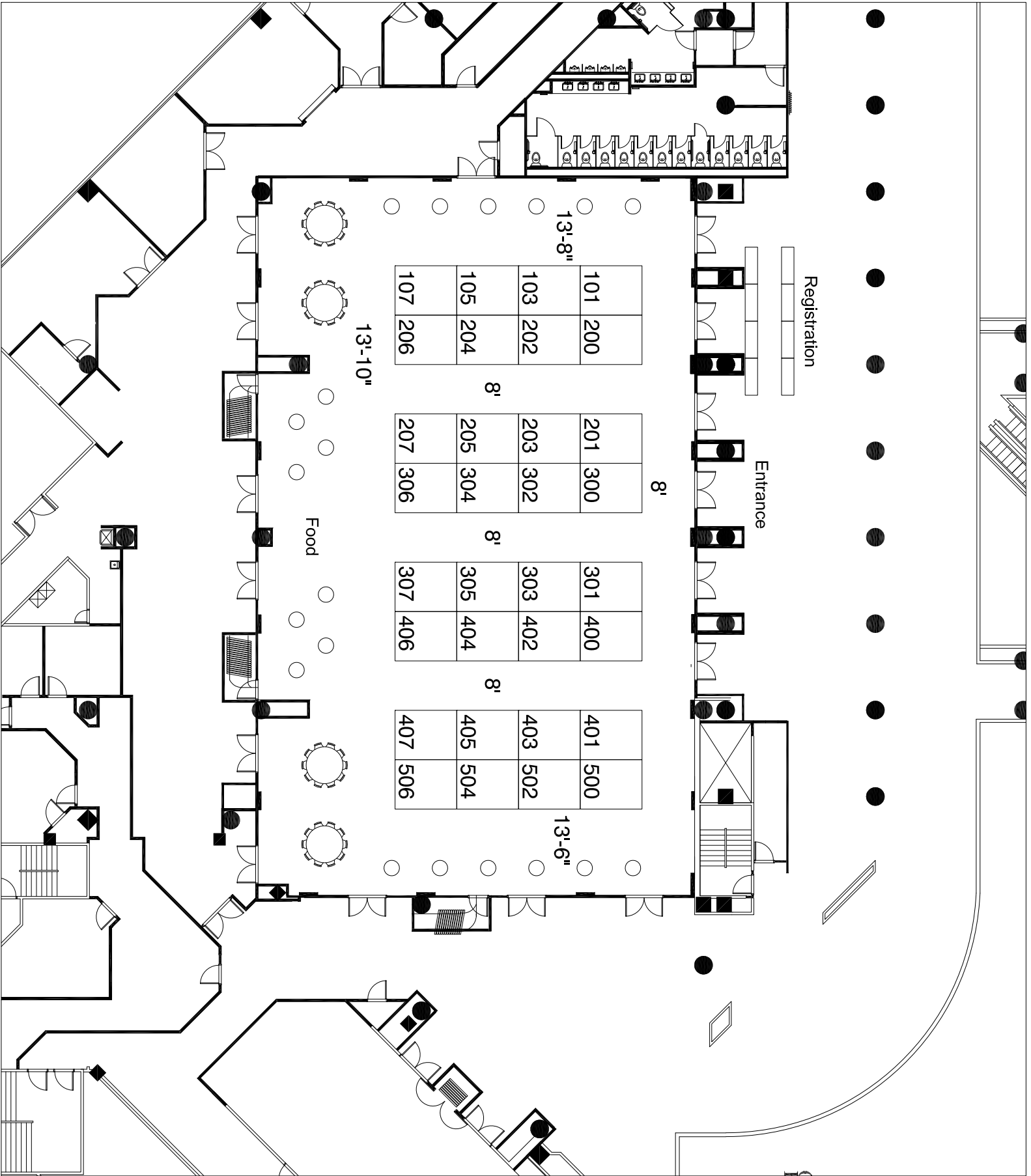
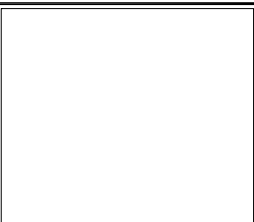
